The Hon'ble Supreme Court of India vide order dated 27/09/2016 in Writ Petition (C) No. 652 of 2016 has granted extension of time for seven days commencing from 01-10-2016, to fill up the seats in BDS course in the Dental Colleges for the Academic Year 2016-17.

In this connection, I hereby direct to all private and unaided Dental Colleges in the State of Maharashtra (excluding Deemed University) as under:-

1. In view of the Hon'ble Supreme Court order dated 27-09-2016, the clause (v) of the decision taken by the Authority in its meeting held on 21<sup>st</sup> September, 2016 at Item No. 1, viz. - "*v) If in any case, any candidates who has secured his/her admission of 1<sup>st</sup> year M.B.B.S. or B.D.S. course in unaided private College for the Academic Year 2016-17 and needs to cancel his/her admission, then he has to cancel it on or before 29<sup>th</sup> September, 2016 by 1500 hrs*", **is not applicable to the candidates who secured his/her admission in B.D.S. course for the Academic Year 2016-17.**
2. On 30<sup>th</sup> September, 2016 at 1400 hrs, if any vacancy arises then the Colleges/Institutes should submit the same to the Office of the Authority from time to time and said vacancy should not be filled by the individual Colleges/Institutes without prior permission of the Authority, the detail directions in this regard will be declared shortly.
