**NOTICE**

In exercise of the powers conferred by Rule 17 of the Maharashtra Unaided Private Professional Educational Institutions (Regulation of Admissions to the Full Time Professional Undergraduate Technical Courses) Rules, 2016 dated 11<sup>th</sup> March 2016 made under the provisions of Section 23 of the Maharashtra Unaided Private Professional Educational Institutions (Regulation of Admissions and Fees) Act, 2015 regarding change in Course or shift or Transfer of candidates (Course or Institute) after first, second or third year of Professional Undergraduate Technical Courses, it is being brought to the notice of all the Principals of Professional Institutions that, they should strictly abide by the relevant provisions of the Rules.

1. As per Rule 17 (1), the list of candidates seeking change in course or shift should be communicated to the office of the Admissions Regulating Authority, by the concerned Principal.
2. As per Rule 17 (2), the transfer of the candidates from one unaided Institution to another unaided Institution, the prior approval should be taken from the Admissions Regulating Authority.
3. The proposals relating to this shall be submitted in the office of the Admissions Regulating Authority at Government Polytechnic Building, 305, 3rd floor, 49, Ali Yawar Jung Marg, Kherwadi, Bandra(E), Mumbai-400051, (M.S.) with all necessary documents and recommendations of the concerned Principal **till 22<sup>nd</sup> July 2016 (excluding holidays), between 10.00 am to 5.00 pm.**
4. Documents to be submitted by the institutions in which candidate is seeking Admissions(Rule 17(2)):-
  - a. Letter of Recommendation of the Principal of the Institution in which the candidate is seeking admission.
  - b. Vacancy position related to the Course
  - c. Applications of the candidates
  - d. No Objection Certificates issued by both the Institutions
  - e. Eligibility certificate from concerned University ( if applicable)
  - f. Attested copies of the relevant marksheet/s
  - g. The reason of seeking such change and the supporting documents thereof.
5. While submitting the proposals, the Principal of the admitting Institution should comply with the provisions as per point No. 17 as specified in the Information Brochure for admission to full time Undergraduate Technical courses, - 2016-17, issued by the State CET Cell.
