- SSC passing Certificate
- First B.A.M.S./ B.H.M.S, Statement of Marks.
- Second B.A.M.S./ B.H.M.S, Statement of Marks.
- Final B.A.M.S./ B.H.M.S, Statement of Marks.
- B.A.M.S./ B.H.M.S, Degree/Passing Certificate.
- Internship Completion Certificate from university or the head of the institution/Certificate indicating likely date of completion of Internship from the head of the institution.
- Registration Certificate (MCIM)/(MCH)/ Receipt of Application to MCIM/MCH
If applicable, Caste Certificate, Caste Validity Certificate, Non Creamy Layer Certificate.

Note: Principal of Colleges and the respective Administrative Officers will be present at the Venue during the Counseling round. Selected Candidates shall be required to complete admission process by paying admission fee of Rs.1500/- in cash and submit their all original documents at the venue itself to confirm their admission.

All the Deans/Principals and Administrative Officers of all Institutes (where even one seat is vacant) are required to be present during this Personal Counseling Round on 15th December, 2016.
