Samiti perused the chart. 1447 colleges have submitted their admission details. 705 colleges have not submitted their admission details upto 31st oct. 2012. Samiti decides that the colleges who did not submit their admission details should submit their explanations as to why they did not submit within a time period of 15 days. Samiti directs the office to scrutinize the proposals and submit them for consideration of Samiti early.

Item No. 3(a) : **Letter dated 18th October 2012 received from Women's Education Society Abasaheb Garware Institute of Management Studies, Sangli requesting to waive the penalty for late submission of merit list for the AY. 2011-12. (Ref : Agenda of 1st September 2012 Item No. 4 (m))**

Samiti perused the letters under reference

It is observed that the aforesaid College/Institute has not given any reason for late submission of the admission details for the Academic Year 2011-12. Penalties therefore cannot be waived.

After deliberation, Samiti directs the aforesaid College/Institute to pay the penalties for the Academic Year 2011-12 first. After receipt of the same it be placed before Samiti for its approval.

Item No. 3(b): **Letter dated 19th October 2012 received from Siddhant College of Engineering Pune requesting to waive the penalty for late submission of merit list for the AY. 2006-07 and 2007-08. (Ref : Agenda of 1st September 2012 Item No. 5)**

Samiti perused the letter under reference.

It is observed that the aforesaid College/Institute has not submitted their Proposals for approval of admissions in time. In view of this the penalty cannot be waived.

After deliberation, Samiti directs the aforesaid College/Institute to pay the penalties for the Academic Year 2006-07 and 2007-08 first. After receipt of the same it be placed before Samiti for its approval.

Item No. 3(c): **Letter dated 15th October 2012 received from Director, Technical Education Mumbai regarding cancellation of admission of Omkar A. Haryan in OBC quota for Academic year 2009-10. (Ref: Agenda of 16th July 2012 Item no. 4 (b))**

Samiti perused the letter under reference. Samiti also perused the letter no. 2A/ADM/2012/2734 dated 15/10/2012 received from Director, Technical Education, Mumbai vide this Letter Director has Communicated that the admission of the candidate under reference deserves to be cancelled in view of the fact that candidates belonging to Vaish Vani Caste were required to be treated as "Open".

Director, Technical Education, Mumbai vide its 2A/ADM/2012/2924 dated 8/11/2012 has however recommended to regularize the admission of the candidate In view of this after deliberation Samiti decides to approve the admission of the student concerned.

Item No. 3(d): Letter dated 18th October 2012 received from Deshbhakt Ratnappa Kumbhar College of Commerce Kolhapur for approval of admissions of first year MBA course for the Academic Year 2011-12.

Samiti perused the letter under reference.

It is observed that the Institute has submitted the proposal for approval of admission after the Last date which was prescribed to be the cut-off date for submission of proposals by Pravesh Niyrantran Samiti.

As per the decision already taken in its meeting held on 5th March 2012, the Penalty of 50% of total fees collected by the Institute for submission of proposal for approval of admission after 31st March 2012 is required to be paid in first.

After deliberation, Samiti decides that the aforesaid College/Institute to pay in the penalty of 50% of the fees collected by them. Thereafter the appropriate decision can be taken.

Item No. 4: To consider the Report dated 23rd Oct. 2012 received from P.V.Page & Co. Chartered Accountants regarding Internal Audit for 2004-2005 & 2005-06 of Shikshan Shulk Samiti and Pravesh Niyrantran Samiti.

Both the Samiti's have since their inception from time to time passed on instructions to charge/recover penalties from defaulter institutions for late submission of their Proposals. The audit of the accounts pertaining to the amounts so recovered and expended from Samiti's funds was not done so far. Office has taken the initiative and started the said work. Report for the year 2004-05 and 2005-06 are now complete and presented before the Samiti. Samiti appreciates the work.

Samiti directs to take necessary steps and complete the remaining work speedily and as early as possible.

Item No. 5(a): Notice (F. No. 2334 of 2012) dated 22nd Nov. 2012 received from National Commission for Minority Education Institutions New Delhi regarding refusal of permission to conduct CET by Association of minority Pharmacy Colleges, Akkalkuwa.

Samiti perused the notice under reference.

After deliberation, Samiti directs the office to submit the report to the petition early.
