Samiti perused the following letters.

3) Letter dated 14th August 2012 received from Association of Management of Unaided Private Medical and Dental Colleges of Maharashtra

Per the order of Hon'ble High Court in Writ Petition No. 7799 of 2010 Association was to follow as under:

- (i) "One set of all such option forms received by such an Association along with a soft copy of total data collected of such option forms electronically by such an Association shall be submitted by such an Association to the Samiti within one week from the last date of submission of such option forms. The Association shall also furnish to Samiti category-wise detailed information as to the total intake capacity of each and every such institutions to which such admissions are to be granted.
- (ii) After duly processing these option forms such Association shall prepare a list of provisional admissions proposed to be granted to such institutions and within three days of such preparation shall submit to Samiti with a soft copy thereof in a sealed cover, all the relevant papers of the proposed admissions to be granted to various such institutions, category-wise, institution-wise, course of study-wise/discipline-wise. The information shall clearly state the full name of the students, requisite particulars as to the marks obtained by the student at the Common Entrance Test and other necessary particulars as may be required by the Samiti."

Samiti observed that the Association did not submit the above information to the Samiti within the stipulated time.

CD submitted by the Association vide its letter dated 14/08/2012 containing the data of first selection list of Asso-CET-2012 for the admission of Health Science courses for the Academic Year 2012 was sent to the Expert Committee i.e. Directorate of Medical Education and Research, Mumbai on $14^{\rm th}$ August 2012 itself at 5.30 p.m.

Expert Committee accordingly has submitted its verification and observation report vide its letter dated 16th August 2012 at 3:11 p.m. (through the fax). Discrepancies pointed out are as under.

a. Observation regarding Preference Form Data

After deliberation Samiti ratifies the decision and on the basis of report of Expert Committee i.e. Directorate of Medical Education and Research, Maharashtra State approves the allotment of students to the colleges as per the first selection list of Asso-CET-2012, subject to removal of the discrepancies pointed out by the Expert Committee as above. Samiti further directs the Association to ensure that the schedule specified is followed as per the directions of Hon'ble High Court, Mumbai.

Item No. 4: To conduct the verification process for Second Selection List of Asso-CET-2012 conducted by Association of Management of Unaided Private Medical and Dental Colleges of Maharashtra as per the decision taken by the Samiti in its meeting held on 14th August 2012 (at Item No. 3) for the admissions to first year Health Science Courses for the Academic Year 2012-13.

As per the decision taken by the Samiti in its meeting 14th August 2012 (at Item No. 3) Association was to submit the data/information of second round of selection process of Asso-CET-2012 on 27th August 2012, but till date Association failed to submit any information in respect of second selection round of Asso-CET-2012.

Samiti therefore directs the Association to submit the proper explanation as to why it did not follow the schedule which was already approved by the Samiti in its meeting held on 14th August 2012 (at Item No. 3) within one week. Samiti further



decides that after receipt of the said explanation from the Association it be placed before Samiti for its consideration.

After receipt of the same explanations to be placed before Samiti for its consideration.

Item No. 5(d): Letter dated nil received from Under Graduate students of Sangam Sevabhavi Trust's Ayurved Mahavidyalaya, Sangamner regarding admissions of the said students in Academic Year 2011-12.
