Item No. 3:

To conduct the verification process for first round of Asso-CET-2014 conducted by Association of Management of Unaided Private Medical and Dental Colleges of Maharashtra – letter dated 26th June 2014 received from Association submitting data of First Round.

Samiti perused the letter under reference as well as 1) Hon'ble Supreme Court order dated 19/05/2014 in Writ Petition (Civil) No(s). 737 of 2013, 2) Hon'ble High Court order dated 11/06/2011 in Writ Petition No. 7799 of 2010 and 3) Verification and Observation report submitted by Expert Committee in respect of the verification process for first round of Asso-CET-2014 conducted by Association of Management of Unaided Private Medical and Dental Colleges of Maharashtra

It is noticed that per the order of Hon'ble High Court in Writ Petition No. 7799 of 2010 Association was to follow as under:

(i) "One set of all such option forms received by such an Association along with a soft copy of total data collected of such option forms electronically by such an Association shall be submitted by such an Association to the Samiti within one week from the last date of submission of such option forms. The Association shall also furnish to Samiti category-wise detailed information as to the total intake capacity of each and every such institutions to which such admissions are to be granted.



(ii) After duly processing these option forms such Association shall prepare a list of provisional admissions proposed to be granted to such institutions and within three days of such preparation shall submit to Samiti with a soft copy thereof in a sealed cover, all the relevant papers of the proposed admissions to be granted to various such institutions, category-wise, institution-wise, course of study-wise/discipline-wise. The information shall clearly state the full name of the students, requisite particulars as to the marks obtained by the student at the Common Entrance Test and other necessary particulars as may be required by the Samiti."

Accordingly Association needs to submit the above information to Samiti before the declaration of first round of Asso-CET-2014. As per the Hon'ble Supreme Court order dated 19/05/2014 in Writ Petition (Civil) No(s). 737 of 2013 1st Round of counseling/admission was to be over by 25th June. CD is submitted by the Association vide its above referred letter on 26/06/2014 at 3.30. p.m. containing the data of first selection list of Asso-CET-2014 for the admission of Health Science courses for the Academic Year 2014-15. It was sent to the Expert Committee i.e. Directorate of Medical Education and Research, Mumbai for their remarks.

Expert Committee accordingly has submitted its verification and observation report on 4th July 2014. Discrepancies pointed out are as under.

A) Observation regarding Preference Form Data

Either HSC-PCB or English marks of 03 candidates are not provided. Out of these 02 candidates are selected in various courses. The details are given below.

B) Observation in respect of a Complaint of Damani Aakash (SML No. 608 – CET Mrarks 161):

It is observed that Association has considered only theory marks of HSC PCB (43.75%) of candidate and not considered practical marks. Hence the candidate was not fulfilling the 50% of HSC-PCB criteria. However after considering both marks (i.e. Theory and Practical marks) the candidate is eligible for MBBS and BDS course. It is observed that candidates with lower SML number are selected in 05 out of 08 preference specified by the candidate. The table below shows the preferences given by candidate and last SML No. allotted to respective college in Open category.

C) Observation from Seat Matrix Data:

Following Institutes are not found in Maharashtra University of Health Sciences, Nashik list as the permitted/affiliated colleges. Out of 50 colleges of B.Sc. Nursing course only 01 college viz. – 526: KDA Nursing College, Mumbai is mentioned in University list of permitted College and Expert Committee pointed out that Association has allotted candidates to these colleges, the details of which are as under:-

It is stated that Samiti in its meeting held on 20th June 2014 at Item No. 4 and 6(a) sub clause (m) had directed the Association that Colleges/Institutes incorporated in the lists need to having all permissions, affiliations of their respective councils, Central Government, Maharashtra University of Health Sciences, Nashik and Government of Maharashtra and students to be allotted to such colleges only.



Samiti observes that contents of letter No. मआविवि/ईओ/पदवी/३०१९/२०१४, dated 30/06/2014 received from Maharashtra University of Health Sciences, Nashik in respect of continuation / extension of affiliation status of Health Sciences Colleges/Institutes for the Academic Year 2014-15.

Samiti further observes that in the first round of counseling Association allotted following students for their admissions as a first preference to Gardian Dental College, Ambernath District, Thane.

However the college reused to admit these students before 3/7/2014 as the last date for joining the college for the students allotted to college in the first round.

Samiti vide its letter No. प्रनिस(वै)/तक्रार/प्रेवेश/३२२ dated 2nd July 2014 had forwarded the said grievance to competent authority, Asso-CET-2014 i.e. Association of Management and Unaided Private Medical and Dental Colleges of Maharashtra and also to Principal/Dean, Shaan Education Society's, Guardian Dental College, Ambarnath, Thane for their say in the matter. It was also endorsed to Director, Medical Education and Research, Maharashtra State for initiating necessary actions.

Expert Committee has submitted its report with the observations of first selection process of Asso-CET-2014 conducted by Association for Health Science Courses for the Academic Year 2014-15. College concerned has also submitted its say vide its letter dated 2/7/2014 explaining its inability to admit the allotted students in view of the fact that the college has no permission to conduct the courses from various authorities.

As per the report submitted by Expert committee it is seen that Association allotted student's to the college's those are not in University's list as permitted/affiliated Colleges.

It is observed that Association has thus violated the directives of Samiti. Samiti feels that the mistakes are serious in nature, as far as the educational future of these students is concerned.

In view of the above, after deliberations Samiti decides and directs the Association as under:

1) Association to consider the complaint of Aakashi Damani as per his actual marks in HSC and should ensure his admission in the appropriate college per his option of choices.

gi)

- 2) Association to submit its explanation to Samiti as to why it allotted the students to colleges which were not found in list of permitted colleges by the Universities within 2 days in the form of an affidavit. It should also explain as to why it failed to satisfy the directions given by Samiti herein before in this connection.
- Association to ensure the admissions of these students first confirm them and then only conduct 2^{nd} round. Till then Samiti will not consider its list for 2^{nd} round.

Office to inform accordingly.

<u>Item No. 4</u>: <u>To consider and decide on the Government resolution dated</u> 13th June 2014 in respect of admission of B.Sc. Nursing

Samiti perused the Government resolution under reference, noted it.

Item No. 5: To discuss, decide and plan for the verification of admission process in Health Science courses for Academic Year 2014-15.

After deliberation, Samiti directs the institutions to follow as under:

- 1) Colleges to follow the schedule of admissions as directed by Hon'ble Supreme Court of India, New Delhi & Hon'ble High Court of India, of Mumbai and respective Authorities.
- 2) The Colleges to submit their admission details online within 15 days after the cut off dates as prescribed by the appropriate authority,.

A. <u>Expert Committees & their role:</u>

1) For Medical & Dental (UG & PG)

Expert committee (PNS) shall be headed by Director, Medical Education and Research, M.S., Director, Medical Education and Research will appoint two other members who shall be drawn from the officers of Medical Education & Research Department and who shall be not below the ranks of Dy. Director.

i) Committee will verify the merit lists of the admitted students, where the admissions have been granted through CAP process for First year Medical and Dental, Where the admissions are done in violation of triple test, same are to be brought to the notice of Samiti.

- ii) Committee will verify the merit lists of the admitted students, where the admissions done through institute level, vacancy against CAP minority quota and Admissions against NRI Quota Medical & Dental (UG & PG). Where the admissions are done in violation of triple test, same are to be brought to the notice of Samiti.
- iii) Committee will submit the reports for Academic Year 2014 to Samiti before 15th November 2014.

B) For BAMS, BHMS, BUMS, BASLP, B.P.TH, B.O.TH, B.Sc, Nursing and P.B.Sc. Nursing (UG & PG)

Expert Committee (PNS) shall be headed by the Registrar Maharashtra University of Health Science (MUHS), Nashik. Considering the suggestion of Expert Committee on the draft brochure, after deliberations, Samiti allows the Association of Management of Ayurvedic Medical Collees of Maharashtra to conduct APGA-CET-2014 for admissions to Post Graduate Ayurvedic courses for Academic Year 2014-15, Subject to the Following:-

 - ii) No. of students qualified in the Exam.
 - iii) No. of participating Colleges with subjects and their sanctioned intake capacity.
 - iv) Course/Subject/category wise seat matrix of each round, before and after rounds.
 - v) List of selected candidates after each round.
 - vi) Details of complaints received during the process and details of action taken by Competent Authority and the Appellate Authority.

Samiti further directs, to incorporate following changes in final Rules and Information Brochure of APGA-CET-2014 as suggested by Expert Committee i.e. Directorate of AYUSH, Maharashtra State, listed in **Annexure - A.**



- Samiti further directs the Association/Colleges/Institutes to follow following in the matter of refund of fees and incorporate the said clause in the brochure:-
 - I) "If a candidate cancels his/her admission before the cut-off-date, then College/Institute has deduct only Rs. 1,000/- as administrative charges and balance amount of fees paid by a student be refunded within two days, otherwise the same amount to profiteering and charging of capitation fees. The Samiti further directs that the College/Institute should also return the original documents / certificates collected from the students within two days.
 - II) If a candidate expires within three months from the date of admission full refund shall be made after deducting Rs. 1,000/- as administrative charges.
