Samiti perused the verification & observation report submitted by Expert Committee – Directorate of Medical Education and Research Mumbai in respect of admissions done in private unaided MBBS and BDS courses for Academic Year 2012-13.

After deliberation, Samiti noted the contents. Expert committee to ensure publication of merit lists was in time. Expert committee also should ensure selection of candidates was as per merit and should satisfy itself about the correct publication of vacancies.

Samiti keeps on hold approval of all the admissions till the final disposal of all undisposed complaints received by PNS in connection with malpractices during admission process of AY. 2012-13.

Item No. 4 : **To consider and decide on Letter dated 22nd October 2012 received from K.J. Somaiya Medical College and Research centre Mumbai regretting the error of NRI Quota admissions in the PG Medical course for AY 2012-13 due to incorrect interpretation. Samiti perused the letter under reference. College has regretted the error of NRI admissions. In view of college having expressed its regrets, Samiti directs it to follow rules, regulations correctly and in letter and spirit and should ensure that no ambiguity creeps in the execution.

Samiti further directs the college to follow rules and regulations laid down by Hon'ble Supreme court, MCI, University, State Government and Pravesh Niyantaran Samiti from Time to Time.

Samiti after deliberation and in concurrence with the suggestions of the member secretary decides that the undisposed complaints be investigated thoroughly by a committee to be appointed by Government under the chairmanship of Dean of the Government college. A member of the committee to be drawn from the respective universities not below the ranks of Registrars and another member to be appointed by Director of Medical Education and Research not below the rank of Jt. Director (He will act as representative of PNS). Committee to submit its report to Pravesh Niyrantran Samiti & Government before 30/11/2012.

Member Secretary & Secretary Medical Education & Drugs Department, Govt. of Maharashtra to ensure that the GR is issued forming the committees and citing therein the expected role of the committee to be formed in the matter. He should ensure issuance of GR early.
